## **Prize Draw Terms and Conditions**

- 1. The promoter of the Prize Draw is The Football Association Limited ("**The FA**"), Wembley Stadium, Wembley, London HA9 0WS.
- 2. Entry into the Prize Draw is dependent on your acceptance of these Terms and Conditions and by entering the Prize Draw you confirm your acceptance of these Terms and Conditions.
- 3. Entrants must be based in the United Kingdom and must be 18 years of age or over on the Closing Date (as defined below). Employees of The FA, any FA Group Company or anyone professionally connected to this Prize Draw and members of their immediate families are not permitted to enter the Prize Draw.
- 4. To enter the Prize Draw, you must already be or become a member of the England Supporters Club.
- 5. - Only eligible entries received between the launch of the Prize Draw at 11am on Thursday 21 April (the "Opening Date") and 5pm on Wednesday 27 April (the "Closing Date") will be entered into the Prize Draw. Entries received after the Closing Date will not be processed.
- 8. All entrants into the Prize Draw confirm, by entering the Prize Draw, that they have the right to submit any image used to enter the Prize Draw in accordance with these Terms and Conditions and that The FA may use any aspect of their entry for any reason (including but not limited to publicity and promotional purposes). - 10. The FA does not accept responsibility for any entries which are lost, delayed, incomplete or otherwise not received or cannot be entered for technical or any other reason. Proof of delivery of the entry is not proof of receipt. Incomplete or illegible entries or those not in accordance with the entry instructions and these Terms and Conditions are invalid.
- 11. There will be one (1) winner of the Prize Draw who will be selected by a judging panel which will include a selection FA Group employees and an independent individual. Entries will be judged on enthusiasm, originality and how effectively the judging panel deems the entrant has embraced the spirit of 'Football Shirt Friday'.
- 12. The Winner will be entitled to two (2) tickets to a game of their choice out of England's three upcoming internationals against Turkey (on 22 May 2016), Australia (on 27 May 2016) or Portugal (on 2 June 2016) (the "**Prize**").
- 13. The Winner will be notified by email, at the email address provided with the relevant England Supporters Club account, on or before 5pm on Tuesday 17 May 2016.

- 14. The Winner must respond and confirm acceptance with The FA by 5pm on Thursday 19 May 2016 in order to claim the Prize. If the Winner does not confirm acceptance within that time period, another winner may be selected. No correspondence will be entered into with anyone other than the winner.
- 15. The FA has the right to select an alternative winner or substitute winner which shall be the next entrant selected by random if: (i) a winner is ineligible to enter the Prize Draw (ii) The FA is unable to reach a winner within the timeframe outlined above (iii) a winner is unavailable to attend their chosen game or the winner does not accept the Prize.
- 16. All prizes are non-exchangeable, non-transferable, and not redeemable for cash or other prizes (in whole or in part). In the event of unforeseen circumstances or circumstances outside The FA's control, The FA reserves the right to offer an alternative prize of equal or greater value. Such decision shall be at the sole discretion of The FA and will be final.

The FA will use the information that entrants provide to process the Prize Draw and if an entrant is a winner the FA may publish their name and town of residence on The FA website and may require them to participate in publicity. The winner of any prize may be required for promotional activity by The FA. - 24. The FA reserves the right at any time and from time to time to modify or discontinue, temporarily or permanently, this Prize Draw with or without prior notice due to reasons outside its control or in exceptional circumstances.

- 27. These Terms and Conditions are governed by the laws of England and Wales. Any disputes arising under or in connection with them shall be subject to the exclusive jurisdiction of the courts of England and Wales.
