

Win Hospitality Tickets for England v Malta at Wembley on 8 October 2016

Terms and Conditions

1. The promoter of the Competition is The Football Association Limited ("**The FA**"), Wembley Stadium, Wembley, London HA9 0WS.
2. Entry into the Competition is dependent on your acceptance of these Terms and Conditions and by entering the Competition you confirm your acceptance of these Terms and Conditions.
3. Entrants must be based in the United Kingdom and must be 18 years of age or over on the Closing Date (as defined below). Employees of The FA, any FA Group Company or anyone professionally connected to this Competition and members of their immediate families are not permitted to enter the Competition.
4. To enter the Competition you must already be or become a member of the England Supporters Club.
5. To enter the Competition you must log into your England Supporters Club account on the England Supporters Club website (<https://englandsupporters.thefa.com>) and upload a photo to the England Supporters Club UEFA Euro 2016 Fan Gallery.
6. Maximum one entry per person and one entry per England Supporters Club account. Entrants found to be using multiple accounts or submitting more than one entry will be ineligible.
7. No payment or purchase is necessary to enter the Competition.
8. Only eligible entries received between the launch of the Competition at 4pm on Monday 13 June 2016 (the "**Opening Date**") and 5pm on Tuesday 12 July 2016 (the "**Closing Date**") will be entered into the Competition. Entries received after the Closing Date will not be processed.
9. All entrants into the Competition confirm, by entering the Competition, that they have the right to submit the image used to enter the Competition in accordance with these Terms and Conditions and that The FA may use any aspect of their entry for any reason (including but not limited to publicity and promotional purposes). Entrants automatically assign all rights in any entry to The FA. All entrants into the Competition waive any moral rights they may have in relation to their entry.
10. The FA does not accept responsibility for any entries which are lost, delayed, incomplete or otherwise not received or cannot be entered for technical or any other reason. Proof of posting the entry on the England Supporters Club website is not proof of receipt. Incomplete or illegible entries or those not in accordance with the entry instructions and these Terms and Conditions are invalid.
11. There will be one winner of the Competition (the "**Winner**").
12. The Winner will win hospitality tickets for themselves and three guests for the England v Malta 2016 FIFA World Cup qualifying match at Wembley scheduled to take place on 8 October 2016 (the "**Prize**"). The hospitality package will be decided and confirmed to the winners once they have been contacted.
13. The Winner will be selected by an independent judging panel which will include a selection of FA Group employees and at least one independent individual (the "**Panel**"). The Winner will be notified via email by Thursday 14 July 2016.

14. Entries will be judged on enthusiasm, originality and how effectively the Panel deems the entrant has embraced the spirit of UEFA Euro 2016.
15. The Winner must respond and confirm acceptance with The FA by 12 noon on Thursday 21 July 2016 in order to claim the Prize. If the Winner does not confirm attendance within that time period, another winner may be selected.
16. The FA has the right to select an alternative winner or substitute winner which shall be the next entrant that is selected by the Panel from the remaining eligible entries if: (i) a winner is ineligible to enter the Competition (ii) The FA is unable to reach a winner within the timeframe outlined above (iii) a winner does not wish to accept the Prize.
17. The Winner agrees to comply with the conditions of entry applicable at Wembley Stadium, and shall ensure that those attending with them do so. Winners or their guests who are rude, abusive or deemed otherwise unsuitable by The FA may be excluded from the Competition or required to leave any ground or stadium.
18. The Winner and their guests must not be subject to any Football Banning Order or equivalent court order and/or criminal conviction which restricts their ability to attend matches and/or makes them unsuitable to accept the Prize. Any winner or their guest subject to such an order or conviction at the time of the match will not be able to receive the Prize and will be treated as having been disqualified from the Competition. Such decision shall be at the sole discretion of The FA and will be final.
19. The FA shall have the right, where necessary, to undertake all such action as is reasonable to protect itself against fraudulent or invalid claims including, without limitation, to require further verification as to the identity, age, and other relevant details of an entrant.
20. The FA reserves the right at its absolute discretion to disqualify any entry which it considers does not comply with these Terms and Conditions or any entrant who it reasonably believes has interfered with the fair running of this Competition, including providing false or misleading information.
21. Entries must be made by the entrant, and must not be made through agents or third parties.
22. All prizes are non-exchangeable, non-transferable, and not redeemable for cash or other prizes (in whole or in part). In the event of unforeseen circumstances or circumstances outside The FA's control, The FA reserves the right to offer an alternative prize of equal or greater value. Travel and accommodation are not included in any of the prizes and The FA accepts no responsibility for any costs associated with any prize which are not specifically included in that prize including, without limitation, meals, personal expenses, insurance and travel expenses in connection with the prize. Winners are strictly prohibited from selling their prizes to any other person.

The FA will use the information that entrants provide to process the Competition and if an entrant is a Winner we may publish their name and town of residence on The FA website and we may require them to participate in publicity. The winner of any prize may be required for promotional activity by The FA. We may send entrants information from time to time about The FA Group and other related football matters and shall process your information in accordance with The FA's Privacy Policy (found at <http://www.thefa.com/public/privacy>), which you are deemed to accept when entering the Competition.

24. No correspondence will be entered into in respect of this Competition except with the Winner.
25. The FA accepts no responsibility for any damage, loss, liabilities (including direct, indirect, incidental, consequential or punitive damage) injury or disappointment incurred or suffered by you as a result of entering the Competition, not being able to enter into the Competition or accepting any prize. The FA further disclaims liability for any injury or damage to your or any other person's computer or IT systems relating to or resulting from participation in or downloading of any materials in connection with the Competition. Nothing shall exclude the liability of The FA for fraud or for death or personal injury as a result of that party's negligence.
26. In no event shall The FA or its Group Company's total liability to you for all damages, losses, or causes of action exceed the price of the relevant prize. Without limiting the foregoing, this Competition and the prizes are provided "as is" without warranty of any kind, either express or implied, including but not limited to, the implied warranties of merchantability, fitness for a particular purpose or non-infringement.
27. The FA reserves the right at any time and from time to time to modify or discontinue, temporarily or permanently, this Competition with or without prior notice due to reasons outside its control or in exceptional circumstances.
28. If any of these Clauses should be determined to be illegal, invalid or otherwise unenforceable then it shall be severed and deleted from these terms and conditions and the remaining Clauses shall survive, remain in full force and effect.
